The Chairperson (Mr Gildernew): Members, I will proceed through the clauses and put the Questions formally. I advise members that, where there are amendments, I will put the Question on the amendment first. If there is not consensus on the Question, I will ask members to vote through a show of hands, and the Clerk will confirm the result of each vote.

Clause 1 (Amendment of abortion on the grounds of disability)

The Chairperson (Mr Gildernew): Is the Committee content with clause 1 as drafted?

Mr Carroll: No.

Mrs Cameron: Yes, Chair.

The Chairperson (Mr Gildernew): There are two different views there, so we are going to put that to a vote.

The Chairperson (Mr Gildernew): Before we go any further, has Alan been put out of the meeting and not been able to rejoin? I wonder what has happened there. [Pause.] He has not been on yet? Okay.

The Committee Clerk: To confirm, I have Pam and Jonathan in favour of clause 1, Gerry and Paula against clause 1, and the rest of the members are not voting. Is that correct?

Mr McGrath: I will be 100% honest. This is my first meeting, and we are near the end of the process, so I have not been able to get the evidence on a lot of the issues. I am going to abstain from these votes today, but I will certainly listen and take a view in the Chamber.

The Chairperson (Mr Gildernew): So what is the outcome, Clerk?

The Committee Clerk: OK. The outcome is that the clause is not supported, because there is not a majority in favour of it. The next question, Chair, is whether the Committee wishes to —

Mrs Cameron: Chair. I see that Alan is in the audience.

The Chairperson (Mr Gildernew): We will bring him up.

Mr Carroll: Chair, did we not vote already, though?

The Chairperson (Mr Gildernew): Clerk, what is your view on that?

Mr Carroll: I do not want to exclude him, but we had the vote already, so surely we cannot have it again.

The Committee Clerk: Chair, my advice is that there may have been an issue with Alan's connection and, therefore, he was not able to get on, as opposed to having left.

The Chairperson (Mr Gildernew): Yes. Given the circumstances of how we went out of the meeting and back in again, we should, to be fair, rerun that vote.
